The Seller agrees to the following terms:

1. The Seller agrees to provide the Buyer with a healthy, socialized and loved puppy. Health, habits and temperament of the puppy will have been disclosed before time of sale.
2. The Seller agrees to sell a puppy that's current on vaccinations and has been dewormed at least three times. Records of vaccinations will be provided by the Seller to the Buyer.
3. The Seller agrees to be available to the Buyer for advice throughout the lifetime of the puppy.

The Buyer agrees to the following terms:

1. The Buyer agrees that it is the Buyer's responsibility to accept the dog as described. The Seller has provided and the Buyer has acknowledged a full disclosure of the health, habits, and temperament of the puppy.

2. The Buyer will keep the puppy as a household pet and provide adequate food, fresh water, safe shelter, affection, and medical care upon sickness, disease, or injury. Maintenance will include an annual health exam and routine deworming and vaccinations as recommended by a veterinarian.
3. The Buyer agrees to keep the puppy as a **pet only** and will spay/neuter their puppy at 20 weeks, or an otherwise appropriate time as recommended by a veterinarian, but no later than 8 months of age. Proof of spay/neuter will be sent to the Seller once done. **Failure to comply will result in the buyer paying an \$800 non-compliance fee to the seller.**
4. The Buyer will provide a collar with tags and a microchip. They will never allow the dog to roam unattended.
5. The Buyer will have **72 hours** from the time of sale to have the puppy examined by a veterinarian. Should the puppy be found unhealthy, the Buyer will have the right to return the puppy for a full refund or exchange for another puppy from a current or future litter **only** with valid proof from a veterinarian.
 - a. Should the puppy present behavioral issues, the stipulation above will be valid but **only** with proof from an animal behaviorist.
6. In the event that the Buyer can no longer care for the puppy, the Buyer agrees to return the puppy to the Seller for the refund of the purchase price minus the deposit. Should the Buyer have had possession of the puppy for two or more weeks the Buyer will forfeit the full purchase price.

The preceding paragraphs contain conditions established by the Seller to ensure the wellbeing of the puppy. The Buyer's agreements will continue for the duration of the dog's life and the Seller will have the right to enforce the agreements.
